

Investing in Saving Lives

Your gift could support patients in your area. Whatever, whether large or small, your gift will make a real difference and assist our vital mission to take on the fight against oesophageal and gastric cancers for present and future generations.



Your Bequest

By making a Will, you can ensure that your estate is distributed according to your wishes. You can provide for your family members for the future; make bequests to friends and even make gifts in your Will to the charities you wish to support.

Inheritance Tax is payable by your estate if its value exceeds the current inheritance tax threshold. However, you can make a substantial bequest to charity and reduce the tax liability on your estate before the tax assessment is made. Your tax advisor will be able to explain and advise you on this.

When you make a Will, you can leave several different types of bequests: You can leave a sum of money, the whole or part of the residue of your estate or stocks and shares.

You can help The Oesophageal Patients Association by making:

- A Residual bequest. Part or the whole of the residue of your estate after all other legacies, expenses, debts and taxes have been paid.
- A Pecuniary bequest, which is the legacy of a specific sum of money

If you decide to support The Oesophageal Patients Association use the following wording in your Will:

For a Residual Bequest:

'I bequeath to The Oesophageal Patients Association (Registered Charity No.1194327) of 6 & 7 Umberslade Business Centre, Pound House Lane, Hockley Heath, Solihull, B94 5DF (.....define portion) of the residue of my estate and I direct that the receipt of the Chair of the Charity for the time being or other authorised officer will be sufficient discharge for my executors'

For Pecuniary Bequest *

If you decide to leave a specific amount to The Oesophageal Patients Association and wish to ensure that inflation does not erode your intention when the Will is made, the following form of words:

'I bequeath to The Oesophageal Patients Association (Registered Charity No. 1194327) the sum of £___, inflation linked to the Retail Price Index from the date of this Will. I direct that the receipt of the Chair of the Charity for the time being or other authorised officer will be sufficient discharge for my executors.'

It is also possible to leave a 'Reversionary Bequest' to charity through leaving all or a proportion of your estate in the care of trustees. Beneficiaries enjoy the income during their lifetimes and all or part of the capital growth could be left to The OPA after their deaths.

*N.B We strongly advise you to seek advice from a solicitor to ensure that you make a legally correct Will. A Will is a legal document.

If you have already made a Will, you can add to it or alter it at any time by adding a codicil.
